Board discussion of Riverside Casino & Resort in Iowa City/Washington, IA. Thams indicated that Elam is making a recommendation that the Board enter into a two year contract with the Downtown Marriott. One important consideration is that locking a deal with this venue for two years will take the responsibility of finding a venue annually off the 'plate' of the incoming president. It should be noted there are cost reductions from the Marriott for this type of arrangement. Lengthy Board discussion followed concerning the pros and cons of a two year arrangement, the Des Moines location, changing the location to the eastern part of the state. June 5th would be the golf outing and the Symposium would be the 6th and 7th. The Marriott has agreed to set aside parking spaces for our event in an attempt to eliminate the parking issues that were experienced this year.
